

# Data protection declaration

## A. Agreement

By accessing the Zeltner & Co. GmbH website, you agree to the information and processing of your personal data in the manner described in this data protection declaration. If you do not agree, do not access our entire website. This data protection declaration can be updated at any time. The updates are binding. By continuing to use the website and our services, we assume that you have taken note.

The following information is also valid for all other information you receive, for example in the form of our newsletter.

## B. General information

Zeltner & Co. GmbH as the operator of this website may involve third parties in its operation. We collect and process your data confidentially and in accordance with the current provisions of the Swiss Data Protection Act ("DSG") and the European Data Protection Ordinance ("DSGVO") as well as this data protection declaration and take the protection of your personal data very seriously. The following explains how your personal data collected during your visit to this website and during any registration is collected and processed.

Our website is generally accessible without providing your personal data.

Your data is processed in Switzerland and is stored on Swiss servers (except Google Analytics).

## C. Which data is collected, how and for what purpose

When you visit our website, the hosting provider of our website, [www.zeltnerco.com](http://www.zeltnerco.com), automatically collects and stores information in so-called server log files, which your browser automatically transmits to us. These are usually:

- IP address
- Browser type and browser version
- operating system used
- referrer URL
- Host name of the accessing computer
- Date and time of the server request

The information/data mentioned is neither assigned to specific persons nor linked to data from other sources. However, we reserve the right to check this data subsequently if we become aware of any concrete indications of illegal use.

All data of this website are stored with our hosting provider, who is located in Switzerland.

We also collect the personal data you voluntarily provide when you register to receive further information on our website or when contacting us by e-mail (in particular e-mail address, name).

Your data is collected and processed for communication purposes, in particular when we inform you about our services and products, as well as for the technical administration, analysis and further development of our website and for the maintenance of our contact database and for marketing purposes.

This data will be kept strictly confidential and will only be kept for as long as a legal basis exists (e.g. consent) or is necessary for the fulfilment of the purposes mentioned.

## D. Other parties who have access to information we collect

With the exception of the provider of our website, we do not make your personal data available to third parties unless disclosure is prescribed or permitted by the applicable law, e.g. to supervisory or other authorities.

## **E. Data security / SSL encryption**

In order to protect your personal data, we have implemented appropriate technical and organisational security measures.

This website uses SSL encryption for security reasons and to protect the transmission of confidential content, such as the requests you send to us as the operator of this website. You can recognize an encrypted connection by the fact that the address line of the browser changes from "http://" to "https://" and by the lock symbol in your browser line.

If SSL encryption is activated, the data you transmit to us cannot be read by third parties.

However, we draw your attention to the fact that any data transmission on the Internet (e.g. communication by e-mail) is generally not secure and we accept no liability for data transmitted to us via the Internet. Unfortunately, absolute protection is not technically possible. It is also possible that data may be transferred abroad and thus at best to a country with a lower level of data protection than Switzerland, even if the sender and recipient are located in Switzerland.

All information does not apply to the websites of third parties and the corresponding links given on our website. Zeltner & Co. GmbH assumes no responsibility and liability for the content and compliance with legal data protection regulations by the operators of linked websites.

## **F. Cookies, Google Fonts and Analytics as well as Social Media Plug-Ins**

### Cookies

### Social media plug-ins

We have configured these elements to be disabled by default. of this operator according to its data protection regulations. We do not receive any information about you from him.

The registrations are logged in order to be able to prove the registration process according to the legal requirements. This includes saving the time of registration and confirmation.

Your personal data will be stored and processed in accordance with Swiss data protection regulations. The secure storage of personal data (e.g. in connection with subscribed newsletters) is guaranteed.

## **I. Legal basis Basic Data Protection Ordinance**

In accordance with the provisions of the Basic Data Protection Ordinance (DSGVO) applicable from 25 May 2018, we inform you that your consent to the dispatch to the e-mail address you provide will be given on the basis of Art. 6 para. 1 lit. a and Art. 7 DSGVO. The corresponding dispatch list is used on the basis of our legitimate interests in accordance with Art. 6 para. 1 lit. f DSGVO. ## **J. Exercise of your rights**

In accordance with data protection law, you have the right to information at any time about the personal data processed and stored by us, its origin and recipient and the purpose of data processing, to correction of incorrect or complete personal data stored by us, and to deletion of these (unless processing is necessary to fulfil a legal obligation, for reasons of public interest or to assert, exercise or defend legal claims).
